Marine Notice No. 63 of 2022

Amended: 08/09/2022 Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

North Irish Sea Array (NISA) Offshore Wind Farm -Geophysical Survey Campaign - Export Cable Route Area, off the coast of north County Dublin and County Meath.

1. Notice of Activity

The Department of Transport has been advised that North Irish Sea Array (NISA) Offshore Wind Farm intend to undertake a **Geophysical Survey** campaign on the proposed NISA Export Cable Route Area, off the coast of north County Dublin and County Meath. The campaign is expected to start on **3**rd **12th September 2022** and finish on **3**rd **12th October 2022**, weather permitting subject to weather and operational constraints.

2. Location of Activity

The survey campaign will be confined to the proposed NISA Export Cable Route area. This area forms an irregular shape spanning 11 km north-south and 18km east-west at its widest point. The survey area has 2 landfall areas close to Balbriggan and surveys will proceed as shallow as approx. 3m water depth. See map at Appendix 1 below.

3. Details of the Survey Vessels

The survey will be conducted by the following Survey Vessels:

- > Geo Focus Survey vessel (call sign PCOS) survey in excess of 10m water depth;
- **Ros Aine** Survey vessel (call sign **EIZG5**) survey in water depth less than 10m.

4. Safety Precautions

As the survey vessels will be **restricted in their ability to manoeuvre** when surveying, due to the deployment of the **towed survey equipment** from the vessel for the duration of the survey activities, all vessels operating within this area are requested to keep a wide berth and pass at minimum speed to reduce vessel wash.

The vessels will display appropriate lights and signals. The survey will utilise multibeam echosounders, sub-bottom profilers, side-scan sonar, magnetometer, both hull-mounted and towed.

Typically, the towed cable lengths will be about four times the water depth while acquiring survey data. The work will be conducted during **24hr operations**.

Mariners are advised to keep continuous watch on **VHF radio channel 16** when navigating the area.
