Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers

North Irish Sea Array (NISA) Offshore Wind Farm -Deployment of Metocean Instrumentation

1. Notice of Activity

The Department of Transport has been advised that Partrac are planning a new deployment of Metocean Instrumentation at the North Irish Sea Array (NISA) Offshore Wind Farm (OWF) to replace the deployment that was notified in Marine Notice No. 03 of 2022. The deployment is now planned to be completed from 16 January to 20 January 2023, subject to weather and operational constraints. On completion of the deployment operations, the equipment will remain deployed for 6 months. Partrac have informed the Department of Transport that they intend to recover two guard buoys, wave buoy and seabed frame from Site A in the week commencing **03 April 2023.** Further to the abovementioned work, they plan on attempting to find and recover a lost seabed frame and anchor in the below site area also

2. Location of Activity

The exact location co-ordinates of the buoys are as follows:

The survey campaign will be undertaken within the proposed NISA OWF area. This area forms an irregular, approximately rectangular shape, spanning 31km north-south and 14km east-west at its widest point. At its closest location, near Rush in Co. Dublin, the array area is approximately 7.4km from the coastline. A map detailing the location is provided below in Appendix 1.

3. Details of Vessel

The operations will be conducted by CT Barnston (Call Sign: MIZU5.). The vessel will be restricted in its ability to manoeuvre. Vessels are requested to leave a wide berth during the deployment operations. Radio transmissions will be conducted with other seafarers to notify them of the operations.

4. Buoy Characteristics

Guard Buoy

Partrac will deploy two Poseidon 1750 Ocean Buoys. The buoy has a hull diameter of 1.75m and height above water level of 2.6m. Both buoys will be yellow in colour and displaying St. Andrew's Cross day shapes. They will be fitted with a radar reflector and a navigation light with a 3Nm range, flashing sequence: Y. Fl. (5) 20s. Both Buoys will be fitted with AIS.

Wave Buoy

Yellow Spherical buoy with a diameter of approx. 1.1m. Buoy Light IALA yellow. Group flashing character of 5 flashes every 20 seconds - FI(5) Y 20s Range of 3nm.


