*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,
Yachtsmen and Seafarers*

North Irish Sea Array Offshore Wind Farm - Geotechnical Survey Campaign off the Coast of Counties Dublin, Meath, and Louth.

1. Notice of Activity

The Department of Transport has been advised that the North Irish Sea Array (NISA) Offshore Wind Farm (OWF) intends to undertake a Geotechnical Site Investigation campaign on the proposed NISA area, off the coast of counties Dublin, Meath, and Louth. The campaign will involve the deployment of Seabed Borehole Drilling and Cone Penetration Test (CPT) equipment from a survey vessel at specific locations within the NISA OWF area detailed below and is expected to be completed between **04 November 2022** and **08 December 2022**, subject to weather and operational constraints.

2. Location of Activity

The survey campaign will be confined to the proposed NISA OWF area. This area forms an irregular shape spanning 23km north-south and 13km east-west at its widest point. At its closest location, near Rush in Co. Dublin, the survey site is 7.4km from the coastline. A map detailing the location can be found in Appendix 1 and a table providing the coordinates can be found below.

3. Details of the Survey Vessel

The survey will be conducted by the “**Fugro Synergy**” Survey vessel (call sign **C6XR3**). As the survey vessel will be restricted in its ability to manoeuvre when surveying, due to the deployment of the seabed sampling equipment from the vessel for the duration of the survey activities, other vessels are kindly requested to keep a wide berth. The vessel will display appropriate lights and signals. The site investigation will utilise CPT and continuous sampling boreholes. The work will be conducted during 24 hr operations. An onboard Fisheries Liaison Officer will be available to discuss operations throughout the duration of the survey campaign.

Mariners are advised to keep continuous watch on VHF radio channel 16 when navigating the area.

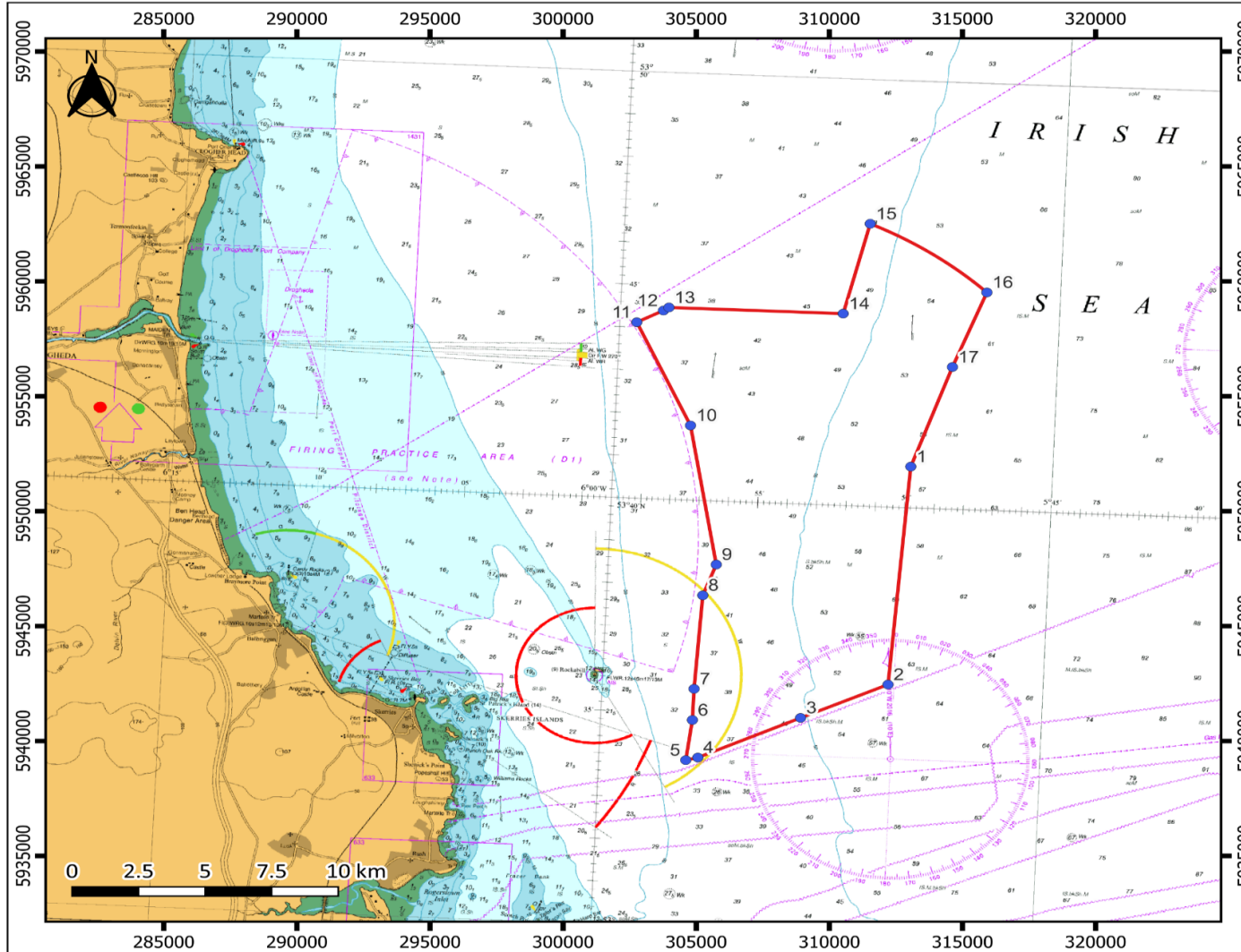

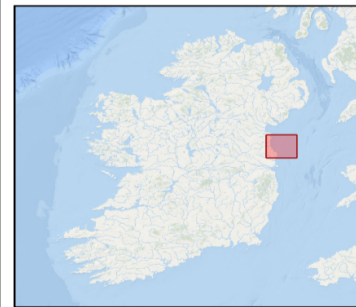
Appendix 1. Map detailing the location of the North Irish Sea Array Offshore Wind Farm
